FROM THE PRESIDENT

Our PTAs work with the school community, day in and day out, to provide programs and support to benefit children and families. They develop programs like the volunteer family art programs, physical education incentives, STEAM assemblies and family nights to educate parents and families about community concerns.

We often forget that PTA has been at the forefront of child advocacy since 1897. A constant reminder to this nation of its obligations to children, providing resources and important information to parents, families, educators and community members. Whenever the education, health, safety, or well-being of children are threatened, PTA members are there, working to resolve those challenges.

For 125 years PTA has been advocating for the health, safety and education of all children and youth.

As we celebrate this Founders' Day let's take a look back at some of the important laws and guidelines that we sometimes take for granted today, such as:

- Creating a separate criminal justice system for juvenile offenders
- Enforcing child labor laws
- Building kindergarten into the public school system
- Supplying federally funded hot-lunches that now feed more than 26 million children a day
- Supporting school bus safety regulations
- Creating the content-rating system for television programs

PTA has never been shy about tackling tough issues – from talking about sex education as early as 1916 to supporting HIV/AIDS education programs in the 1980s; from including authentic family engagement in California's education code to working with state/local leaders and school districts to get computers and devices, internet access and hotspots and school meals to children and families who needed them during the pandemic.

On February 17, 2022 as we celebrate the birthday of PTA, let us remember to plant the seeds for our future, developing leaders, so that we may have 125 more years of improving the lives of children through PTA.

Durante 125 años, la PTA ha defendido la salud, la seguridad y la educación de todos los niños y jóvenes. Mientras celebramos este Día de los Fundadores, hay que ver algunas de las leyes y guías importantes que a veces damos por hecho hoy, como:

- Crear un sistema de justicia penal independiente para los delincuentes juveniles
- Hacer cumplir las leyes de trabajo infantil
- Integración del Kinder en el sistema de escuelas públicas
- Suministro de almuerzos calientes financiados con fondos federales, que ahora alimentan a más de 26 millones de niños al día.
- Respaldar las normas de seguridad de los autobuses escolares
- Creación del sistema de clasificación de contenidos para programas de televisión

La PTA nunca ha sido tímida a la hora de abordar temas difíciles, desde hablar sobre educación sexual en 1916 hasta apoyar programas de educación sobre el VIH/SIDA en la década de 1980; desde incluir una participación familiar auténtica en el código de educación de California hasta trabajar con líderes estatales/locales y distritos escolares para obtener computadoras y dispositivos, acceso a Internet y puntos de acceso y comidas escolares para los niños y las familias que los necesitaron durante la pandemia.

El 17 de febrero de 2022, mientras celebramos el cumpleaños de la PTA, recordemos plantar las semillas de nuestro futuro, desarrollando líderes, para que podamos tener 125 años más de mejorar la vida de los niños a través de la PTA.



MEMBERSHIP AND ORGANIZATION

I think many of us thought 2022 was going to bring us a re-emergence from masks and lockdowns, unfortunately those hopes were quickly dashed, but that doesn't mean we stop moving forward and continue to look for better days ahead.

Here are some updates from our M&O committees:

Membership

Hopefully you have made it through several of the stops on the State Membership Drive Challenge Road Map. Here are some of the upcoming due dates. You do not have to participate in all the challenges. If you have not previously participated, jump in with the Founder's Day Challenge. You can find the roadmap at capta.org.

Make your road trip special and set a new record for your school. Any PTA unit, council or district that has a membership total by **March 31, 2022**, that is higher than any year-end total since the 2016-2017 membership year, will be awarded a



certificate of recognition and will be entered into a drawing to receive one of five \$200.00 awards.

5. Founders' Day Membership Challenge

PTA Founders' Day is February 17. Any unit that submits, through channels, 17 new memberships for the month of February will earn a certificate. No application is required. <u>The deadline is March 1, 2022.</u>

6. Best in 5 Award

Any PTA unit that has a membership total by March 15, 2022, that is higher than the largest year-end total since the 2016-2017 membership year, will be awarded a certificate of recognition, will be recognized on California State PTA social media platforms, and will be entered into a drawing to receive one of five \$500.00 awards. All units that qualify for the Best in 5 Award will also receive a recognition ribbon at the 2022 California State PTA Convention. No application is required. The deadline is March 15, 2022.

7. Club 100 Award

For units that have membership that is 100% or more of their school student enrollment by the deadline, will be awarded the Club 100 Award and will receive a banner for their unit to commemorate their success.



Club 100 Award winners will also receive a recognition ribbon at the 2022 California State PTA Convention, membership marvel pins for their board members, and be entered into a drawing to receive one of ten \$100 prizes. The unit must submit a <u>Club 100 Award application</u>. The deadline is March 15, 2022. If a unit/council/district earns this award after the March 15, 2022, deadline, said unit/council/district is entitled to a banner for their success.

8. Membership Marvel Award

Any unit that increases its membership by 10% over its 2020-2021 membership total will earn the Membership Marvel Award. Each unit board member will receive a Membership Marvel pin and each unit will receive a certificate of recognition. No application is required. <u>The deadline is April 15, 2022</u>

9. Community Connection Award

This award is given to units that have 10% or more of their membership comprised of non-traditional members such as business and community leaders who do not have children at the school. (Parents, family members of students, teachers and staff are considered traditional members for purposes of this award). Community Connection Award winners will receive a certificate for their efforts. A <u>Community Connection Award</u> <u>application</u> must be submitted to win. <u>The deadline is May 15, 2022.</u>

MUSIC SCHOLARSHIP COMMITTEE

The Darlene Panfill Music Scholarship Program is a 31st District tradition, dating back to 1953 with the inception of the 31st District. This program is funded through the generous donations from our PTA Units. The auditions just took place on February 5th with professional judges on hand for the auditions.

Welcome back!

Your Leadership moment. Elections season is here. I know, you all just took office. Some of you are still learning your jobs and I am talking about elections for next year... Yes!

Election calendar:

January - nominate your Election Committee at the Association Meeting. Once they are set, have them meet with your Parliamentarian - if you don't have a Parliamentarian, your President can meet with the committee. They will review the bylaws with the committee, establish the roles that need to be filled and provide the membership list. Then they step away and let the committee set the slate.

February - the nominating committee will present their slate of officers to the Association and then post the notification in a public place - either on campus or in the PTA's social media. The goal is to fill all positions however in the event the committee cannot fill a position, they still present the slate of officers they were able to procure commitments from. Open positions can be filled from the floor at the actual election, which will take place in March.

Once elected in March, the incoming board can start their training, determine if they would like to attend convention and start planning for 2022-2023. While they don't actually make decisions until they take office July 1, 2022 - this is critical planning time.

NOMINATIONS AND ELECTIONS

The purpose of the nominating committee is to recognize and seek qualified nominees for the elected leadership of the PTA. The members of the committee, therefore, have a tremendous influence on the future of the PTA and should be selected carefully.

NOMINATING COMMITTEE BASICS

The nominating committee is the only PTA committee that is not appointed by the president. This committee is elected by the membership at least two months prior to the election of officers. Determining when to elect the committee and how many people to elect is outlined in your unit bylaws. Don't forget to elect alternates, in the event an elected committee member cannot attend a committee meeting. Most units should be electing the nominating committee no later than January or February for the election of officers in March or early April. The committee needs a balance of newer and more experienced PTA members, all of whom should be knowledgeable about PTA and who are:

- Aware of qualified potential nominees Familiar with the eligibility requirements and the qualifications necessary for the offices to be filled
- Willing and able to devote adequate time to the responsibilities involved and maintain confidentiality.
- Don't overlook student and teacher members
- The election of the nominating committee should not be a popularity contest based on willingness to serve nor should it consist of the PTA executive board. The PTA president never serves on the committee, and the parliamentarian serves only when elected to serve. The principal may be elected, but should at least be an advisor to the group. No person may serve on the committee for two consecutive years. Be sure to elect your nominating committee wisely!

QUALITIES OF NOMINATING COMMITTEE MEMBERS

Nominating committee members should be:

- Elected on merit and ability.
- Willing to devote adequate time to the responsibilities involved.
- Knowledgeable regarding the eligibility requirements and the qualifications necessary for the offices to be filled as well as the responsibility of each office.
- Aware of the qualifications and abilities of potential nominees.
- Able to give objective consideration to nominees.
- Able to use sound judgment and skill in evaluating nominees.
- Tactful, discreet with integrity.
- Able to keep all deliberations confidential.

DO's AND DON'Ts

- DO: Study carefully the qualifications of members before presenting the name as a nominee.
 - DON'T: Submit a member's name as a nominee because she/he is a friend of yours.
- DO: Check the membership list to be sure nominee is a member of the organization.
 - DON'T: Nominate a person with the thought that it is a good way to get him to join the PTA.
- DO: Remember that committee DISCUSSION is left in the meeting room.
 - DON'T: Repeat what was said in the committee meeting to anyone.
- DO: See that the report of the nominating committee is publicized through the proper channels.
 - DON'T: Report the results of the nominating committee until it has been publicized through the proper channels.
- DO: Accept an office yourself if you are sincerely interested in the purpose of the organization.
 - DON'T: Accept the office if you are only interested in having your name in the yearbook.



NATIONAL PTA FOUNDERS' DAY



HAPPY BIRTHDAY PTA! May you Live Forever and Strong! February 17, 2022, marks the 125th Anniversary of the founding of PTA.

Founded as the National Congress of Mothers by Alice McLellan Birney and Phoebe Apperson Hearst, National PTA (www.pta.org) is a powerful voice for all children, a relevant resource for families and communities, and a strong advocate for public education.

On February 17, 1897, more than 2,000 people—mostly mothers, but also fathers, teachers, laborers and legislators—attended the first convocation of the National Congress of Mothers in Washington, D.C. Twenty years later, 37 chartered state congresses existed.

In 1926, Selena Sloan Butler formed the National Congress of Colored Parents and Teachers to advocate for children, especially African American children in segregated communities. As the United States progressed through the Jim Crow era, the Civil Rights Movement and the eventual desegregation of schools and communities, the two associations fought side by side for every child.

Following the Supreme Court decision that ended segregation, the Associations held their conventions in conjunction with one another and worked toward merging in all 50 states. On June 22, 1970, the two congresses, National PTA and the National Congress of Colored Parents and Teachers (NCCPT), signed a Declaration of Unification and officially became one association, and merged their visions to serve all children.

The unification of the two congresses is an important part of National PTA's history and the association's continued efforts to serve and make a difference for every child.

Founders' Day, celebrated by National PTA on February 22, 2022, is when we celebrate the legacy and work of our founders —Alice McLellan Birney, Phoebe Apperson Hearst and Selena Sloan Butler — to improve the lives of all children and families.

Founders' Day is a time to reflect and take pride in our achievements, and renew our commitment to be:

- a powerful voice for all children;
- a relevant resource for parents; and
- a strong advocate for public education.

PTAs FOCUS OF SUCCESS

This year we are celebrating 125 years of working on behalf of children and families. Our history informs our work. Today's PTA is vibrant and active and includes a network of millions of families, students, teachers, administrators, and business and community leaders devoted to the educational success of children and the promotion of family engagement in schools.

- Student and School Success All students should receive a world-class education that prepares them for long-term success in college and careers. PTA programs like Take Your Family to School Week, Family Reading Experience and School of Excellence empower families to be engaged in their children's education and support their learning, which makes a difference for student success and school improvement.
- Health and Safety Every child should have a healthy and safe place to live, learn and thrive. PTA provides tools and resources—such as our Connect for Respect initiative—that help students, parents and schools work together to create a positive school climate.

PTA celebrates and raises awareness about the importance of arts education and provides all students the opportunity to explore and be involved in the arts through our annual Reflections program.
- Advocacy All families should be at the table and empowered to advocate for their own and every child.

As the largest volunteer child advocacy organization in the nation, National PTA is the conscience of the country for children and youth issues. Through advocacy, as well as family and community education, National PTA has established programs and called for legislation that improves our children's lives, such as:

- Child labor laws
- Public health service
- Hot and healthy lunch programs

- Juvenile justice system
- Mandatory immunization
- Arts in Education
- School Safety


FOUNDERS' DAY RESOURCES

As a PTA there are many programs and special events that you can utilize and celebrate big or small in your unit. This section is designed to highlight the bigger National PTA events and programs. You'll find both ideals and resources to help make your year a success.

Take time to reflect & celebrate our accomplishments and renew our commitment to be a powerful voice for all children, a relevant resource for parents, and a strong advocate for public education.

Here are just a few examples of Founders Day activities. Utilize the internet to see what other units and councils are doing across the nation. There is no one "right" way to celebrate.

- Annual dinner hosted by council for PTA unit officers and school district employees.
- A district event that the local units take turns hosting.
- Have birthday cake, invite all the past presidents of the unit and recognize them with a small gift.
- Recognize PTA Hall of Famers (a special principal, teacher, staff member or volunteer) who has made positive differences in the lives of children. You can honor them with a PTA Distinguished Service Award.
- Donation of a book to the library in honor of someone who exemplifies what PTA stands for.
- Ask local businesses to post "Happy Birthday PTA" on their outside signs.
- Showcase students' Reflections projects at your meeting/event and don't forget to make students feel welcome to attend.
- Request your town's mayor issue a proclamation in honor of PTA's birthday. Invite him or her to attend the meeting with their family and sign the proclamation during the event.
- Showcase achievements and highlights of your PTA with a Power Point presentation, collage of pictures or scrapbook display. Distribute a list of these achievements and future goals.
- Offer the opportunity to make a freewill donation to your local PTA Scholarship fund.
- Have a creative and meaningful way to collect the Founders Day Gifts, i.e. a collection box that looks like a wishing well or school house. Make sure the purpose of the gifts is clearly stated.
- Ask students to create a presentation or video about ways PTA has influenced their education.
- Begin your own local PTA Hall (or wall) of Fame. Honor those that have made significant contributions to your unit. Make a decorative bulletin board that features their pictures and achievements. Begin a tradition that your PTA can add to each year.
- Hold a candle light ceremony in recognition of the founders' inspiration and to honor past unit presidents.
- Ask three female students to dress as our "founding mothers" as part of your event.
- Ask the choir or a band ensemble to perform for your event.

- 15. Ask current members to renew their membership for next year, before the current school year ends. Retain members from current year, so you can focus on recruiting new members the next school year.
- 16. Every member gets a member! Challenge current members to share the PTA value and ask others to join.
- Create a welcome letter at the beginning of the year letting families know what PTA does for their kids and school. Update everyone mid-year
- 18. Create a PTA welcome packet for new students and families Put a "personal membership invitation" in the school's back to-school mailing.
- Work with the school's Parent Resource Center to ensure all families get PTA information and messages.
- 21. Connect with preschools that feed into your school and ask them to share info about your PTA with the families of graduating students.
- 22. Middle and high school PTAs can reach out to the PTAs that feed into them to connect with families whose kids are moving to their schools.
- Encourage members to bring a friend to PTA meetings, activities and events.
- 24. Have PTA shirts and/or name tags for the board, so everyor knows who you are at school and PTA events and provide members with name badges to wear at meetings/events
- 25. Make sure everyone understands that only members are allowed to vote at PTA meetings. Then encourage people to join so their voice is heard.
- 26. Make sure people know that they can join PTA without volunteering

- 27. Make volunteer sign-up easy. Always have a sign-up form available in person and/or online. When people sign up who are not members, ask them to join
- 28. Coordinate PTA membership drives and events with nportant school events/activities
- Include a link or QR code to join on all PTA communications, and if possible, school communications too.

HOW TO HOLD AN ELECTION MEETING

From California PTA



Each year, PTAs elect officers for the next term at an association meeting. The month to hold the annual election meeting is listed in a unit's Bylaws and is usually no later than the second week of April.

This date helps ensure a smooth transition for incoming board members. It provides time for them to receive materials and talk about the scope of their new position with their predecessor. And, it lets members of the board-elect get started to plan for the upcoming PTA year.

As well, the date gives the president-elect time to register and attend the California State PTA Convention. The annual election meeting is planned and run by the president.

Here are some tips to prepare for an effective election meeting:

- 1. Agenda Put 'Election of Officers' under 'New Business' on the Agenda.
- 2. **Notice** Distribute written notice of the election meeting thirty (30) days in advance to the unit's members as stated in the Bylaws
- 3. Membership List Secretary brings a current Membership list to the meeting to verify eligibility to vote
- 4. **Voting** Only unit members attending the meeting, who have been members for at least thirty (30) days, and whose dues are paid, are eligible to vote at an election.
- 5. **Nominations at Meeting** After presenting the slate of nominees, additional nominations must be called for from the floor as indicated in Bylaws. These nominations do not require a 'second' and eligible members can nominate any current PTA member.
- 6. **Elected Officers** To be elected requires a majority vote of those present and eligible to vote, providing the meeting quorum, as stated in Bylaws, is met.

How a PTA election is conducted is based on standard, parliamentary procedure. After giving some opening remarks, the president:

Asks parliamentarian to read parts of the Bylaws, Nominations & Elections (Article V, 1, 2, 4a, 4e, 5 to 8 and 11) Asks for Report of the Nominating Committee

- Chairperson reads report and notes any changes to publicized slate, if a nominee withdraws before the election.
- o Restates slate of nominees and asks each one to stand as name is called
 - Asks for and takes nominations from the floor

Says, "Are there any further nominations? Ends process by saying, "Hearing none, the nominations are closed". Conducts election of officers:

- With one nominee for each board position, use a voice vote, saying:
 - "Bylaws state that if there is one nominee for an office, a ballot may be dispensed with and the election held by voice vote."
 - "Any objection to this procedure?"..."Hearing none, the following are presented for election" and reads list of positions and nominees."
 - "All those in favor, say 'aye,' those opposed say 'no'. The ayes have it. Congratulations, you have elected the officers for next term as presented."

HOW TO WELCOME DIVERSE PERSPECTIVES INTO YOUR PTA

From California PTA

PTAs are strongest when their leaders and members reflect the diversity of their own communities. Multiple perspectives help to solve tough problems by bringing a variety of solutions to the table. Try these five strategies to help build a more inclusive PTA

- 1. Learn more about the community your PTA is serving.
 - a. Don't assume you know what is happening in the community or that you understand the different cultures represented.
 - b. Do ask questions to understand:
 - i. What are the different cultural values of families in the community?
 - ii. What languages other than English do families in our community speak?
 - iii. Are the PTA and school mindful of the diverse needs of families?
 - iv. What are some of the stigmas that could affect PTA involvement?
- 2. Avoid tokenism.
 - a. Don't ask a parent to be the lead of a subgroup simply because they belong to it. Your one international parent that is a PTA member shouldn't be in charge of inviting the other parents to the multicultural festival.
 - b. Do reach out to minority populations within your school for all events. The outreach should be performed throughout the year, not only for multicultural events.
- 3. Build trust.
 - a. Don't assume you are in a position of trust because you are a PTA leader.
 - b. Do work on building a meaningful relationship with stakeholders and families.
 - i. Open up first and share your personal story.
 - ii. Be mindful of hesitations to provide input or information. This can be due to immigration concerns, data privacy or basic lack of trust.
 - iii. Build partnerships with trusted community leaders or influencers by approaching local community meeting places to offer support, such as churches, community centers, community organizations, libraries, etc.
- 4. Cater to the needs of the community.
 - a. Do ask questions to understand their needs. For example, immigrant families or families of kids with special needs may need additional information about navigating the sometimes complicated school system.
 - b. Don't approach families about the benefits of PTA membership without knowing their needs.
- 5. Find alternative meeting locations.
 - a. Don't assume that the school is the most convenient place to meet. There may be fear, discomfort or lack of trust in going to the school. This may range from a parent who fears the school may question their legal status, to a parent who has not had a positive experience at the school.
 - b. Do offer families alternate options such as community centers, a church or even a virtual meeting.

FROM THE COUNCILS

TIPS TO ATTRACT LOCAL LEADERS

From California State PTA



One of the wonderful benefits of belonging to PTA is the superb support system it offers. Thank you for the time you have chosen to give to your PTA and school community. Being a PTA leader can sometimes feel a little overwhelming and complex. But knowledge is a powerful tool.

1. Hone your leadership team's skills.

PTAs throughout California are seeking individuals who will step back into the limelight by not only joining PTA, but volunteering in some capacity to support their school and its families, and further their PTA goals.

Having knowledgeable, welcoming leaders will encourage your PTA members to

join the team. Training develops officer leadership and teamwork skills, so do take the time to find and participate in any trainings available from your District PTA. But first, review Tips for Leaders from the California State PTA.

In addition, the 2021-22 Welcome Packet local leaders received from California State PTA includes *RUNNING YOUR PTA...Made Easy*. This 24 page, easy to read document is your roadmap for successful goal setting, executive board and association meetings, leadership practices, officer tips, inclusivity, finances, bylaws, and calendar planning. Share it with your board via this link (or this link for the Spanish version). You can also request copies through your District PTA president. The California State PTA "Welcome Packet Homepage" includes specific items for your PTA leaders: president, treasurer, parliamentarian, and communications.

2. Consider doing less this year.

The executive board should consider if past supported events and fundraisers are too intimidating this first year with students back on campus. It may be wise to scale back the number of events to between three and five for the remainder of the year, and ask for participation. Also, be sure to include a social, fun event. Your community's social well-being is important, just like student social well-being. Events done well will encourage others to step up.

3. Make participation easy.

More members may be working from home, but don't assume they have more time. After being home bound some are hesitant socially to step out.

Look at ways to divide the work into smaller, less threatening tasks with shorter timeframes. For example, subdivide the hospitality chair role into the events: winter, spring, and summer association meetings, Founders Day, Staff Appreciation, etc. For fundraising consider a chair for each activity.

Refer to the California State PTA Toolkit for more than 28 suggested Job Descriptions for PTA leaders. You can adjust these to suit your goal.

4. Use the buddy system to get the work done.

Every PTA association officially needs to have a president, secretary, and treasurer. If your PTA doesn't have an executive vice president, corresponding secretary or financial secretary, these three positions, already included in the standard bylaws, were created to provide support and divide the work. Updating

your bylaws is easy using California State PTA's electronic eBylaws program to add these positions permanently. In the meantime, the president may appoint an assistant to any officer for support, with or without attendance and full voting rights at executive board meetings. Consider these guidelines when appointing committee chairs and assistants.

5. Expand your reach through purposeful inclusion.

Does your PTA embrace individuals included in your school community?

If families at your school speak many languages, seek volunteers who will help engage those families. Parents of students with special needs often feel left out when they cannot leave their children at home with a child care provider. Ask your officers and school staff which tasks can be done at home by eager volunteers.

Don't forget students have great talent and energy. Middle school and high school students can be PTA members and they can be volunteers as well. They can get a lot out of that involvement.

6. PTAs can and should be creative.

More often than not, the new idea you have has been done before. Reach out and connect with nearby PTAs and your council and district PTA to share ideas and success stories and pool your resources.

VISITING YOUR LEGISLATOR

We recommend making an appointment to visit your state and federal legislative representatives at least once per year. Call their district offices to find out when they will be available; many state legislators spend Fridays in their district offices. Arrange for a group of PTA members to visit and share information about what is important to students and parents in your area; include students when they are available.

When visiting your elected representative, take the following steps:

- Schedule an appointment or, if the elected representative is unavailable, arrange a meeting with the aide handling the issue. When making the appointment, specify how much time will be needed.
- Draft an agenda and be sure to list the issue(s) the PTA wants to discuss. If PTA members are visiting as a group, assign each person a role. For example, one person can open the meeting, another person can be the recorder, someone else can focus the conversation back to the PTA agenda when necessary, and another person can leave literature.
- Arrive on time for the meeting. Have the group meet together immediately prior to the meeting and then go in together. Once in the meeting, immediately identify yourself and the PTA represented. During the introduction, state the issue(s) of concern. Keep the time frame in mind during the meeting.
- Be prepared to educate the legislator or aide about PTA's history and positions. Be open to questions. If you don't know the answer, politely explain that you will do some additional research and get back to them. Never give false information or assumptions. Personal credibility and the credibility of PTA are on the line.
- Ask how the legislator will vote on the issue. If the legislator is unable to make a commitment, tactfully state that you would like to know, and that you are willing to call at a later time to learn the decision. If the response is positive, respond, "We appreciate your support." If the response is negative, ask, "What are your specific objections?"
- Develop a positive relationship with elected representatives and their staff members. Communication should be a continuing exchange, not sporadic contact. A solid relationship with legislators and their staff members is an important step in building credibility and power for the PTA.

NATIONAL PTA ANNOUNCES ALLIANCE WITH DISCORD IN SUPPORT OF TEEN DIGITAL SAFETY AND WELL-BEING

Alexandria, Va., (Jan. 13, 2022)—National PTA is pleased to announce an expansion of its <u>PTA Connected</u> <u>initiative</u> through a new alliance with Discord, an online voice, video and text communication service on a mission to create a space for everyone to find belonging. Discord will collaborate with National PTA on digital safety resources and events designed to elevate youth voices and foster shared understanding among teens, caregivers and educators.

As part of the alliance, National PTA and Discord kicked-off their alliance with a live digital safety session Wednesday, Feb. 9th during PTA's weeklong commemoration of <u>Safer Internet Day</u>.
