



2020 California State PTA Convention First-Timer Scholarship

Applications due by March 1st, 2020.

Scholarship Information

- 31st District PTSA will be awarding two (2) scholarships for first time attendees to the California State PTA Convention.
- A maximum of \$700 per person will be awarded as a reimbursement after receipts are submitted with an expense form and convention report.
- Award must be used to cover convention cost, including registration, travel, accommodations, food and additional related expenses.
- Receipts, expense forms and convention reports must be received by the 31st District Office no later than June 1, 2020 (late submission will disqualify reimbursement).
- This scholarship once awarded and accepted by the recipient is **NOT transferable**.
- If you cannot attend once your travel arrangements have been processed by the 31st District PTSA, you will be responsible for expenses incurred.

Eligibility

Applicant Must:

- **not** have attended a California State PTA convention before.
- be a PTA/PTSA member of a unit within the 31st District PTSA.
- currently hold an office in either a unit or council, that is in good standing at the time of application.
- be able to attend the entire 3-day convention.
- attend all sessions and workshops. Any violations to this agreement will result in reimbursement to the 31st District PTSA for expenses incurred.
- Be at least 18 years of age
