- 1 **REMINDER: Draft Resolutions Due** - draft resolutions and convention action cover sheet due to the California State PTA office. The resolutions offer official guidance on issues as wide ranging as school-finance topics, health and safety issues, community concerns and more. - 1 **REMINDER: Reflections Theme Search Entries Due** – From the nationwide search, one exceptional theme will be selected to inspire creativity in Reflections Program participants. The theme will be announced by National PTA in June 2020 and the student who submits the winning entry will receive \$100. - 15 **DUE: State & Federal Taxes** - IRS Form 990, 990EZ, & 990N are due November 15, 2019. *All PTA/PTSAs must file a tax return every year.* Arrange for a paid tax consultant to assist your unit in preparing the tax return, if necessary. Send 2 copies of tax filings to your Council Treasurer and keep one for your files. - 15 **DUE: RRF-1 (Charitable Trust)** - RRF-1 must be filed by all PTAs with a Charitable Trust (CT) number with the California Attorney General Registry of CT. Visit <https://capta.org/pta-leaders/services/tax-filing-support-center/tax-filing-what-to-file/> for more information



- 15 **DUE: Insurance Premium Remittance** - General Liability, Directors and Officers Liability, Bonding, and Workers' Compensation Insurance Premium are due to Council Treasurer. Amount due \$ 232.00 (UNITS). After December 1<sup>st</sup>, a \$25.00 late fee will be assessed by California State PTA, to maintain a unit in good standing.
